Developing tribal capacity to understand and conduct research and evaluation in tribal communities is an exercise in sovereignty. These resources can provide information to get you started.

A Roadmap for Collaborative and Effective Evaluation in Tribal Communities

This comprehensive guide represents a shared vision for the future of tribal child welfare research and evaluation. Collaboratively developed by tribal child welfare administrators, academic and community evaluators and researchers, TA providers and federal partners, the roadmap highlights tribal sovereignty and the meaningful inclusion of tribal voices to enhance tribal research and evaluation capacity.

Exploring Pathways to Trust: A Tribal Perspective on Data Sharing

Tribal perspectives emerged from a discussion on federal data access and the collection, management, and use of secondary data in the context of university-tribal research/evaluation partnerships. Authors describe how to hold partners accountable through the use of data-sharing procedures that respect tribal sovereignty and tribal oversight of research/evaluation.

Making Decisions about Genetics Research: A Guide for American Indian/Alaska Native Communities

This interactive tool from NCAI can assist tribes make research/evaluation decisions that support tribal sovereignty. While the primary focus is on genetic research, the same protocols can apply to other research and evaluation efforts. Tribes can use this guide to help:

- Define guiding values,
- Decide if participation is right for them (with questions for <u>individuals/communities</u> to determine their own views and <u>questions</u> <u>tribal leaders can reflect upon</u>), and to
- Review <u>cases and examples from other</u> Tribes.

Walk Softly and Listen Carefully, Building Research Relationships with Tribal Communities (NCAI, MSU)

This document provides practical advice for those tribes who are interested in developing research and evaluation capacity. Authors emphasize the importance of building trusting community relationships in order to effectively develop an indigenous community-centered approach.
