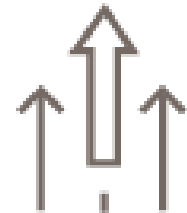

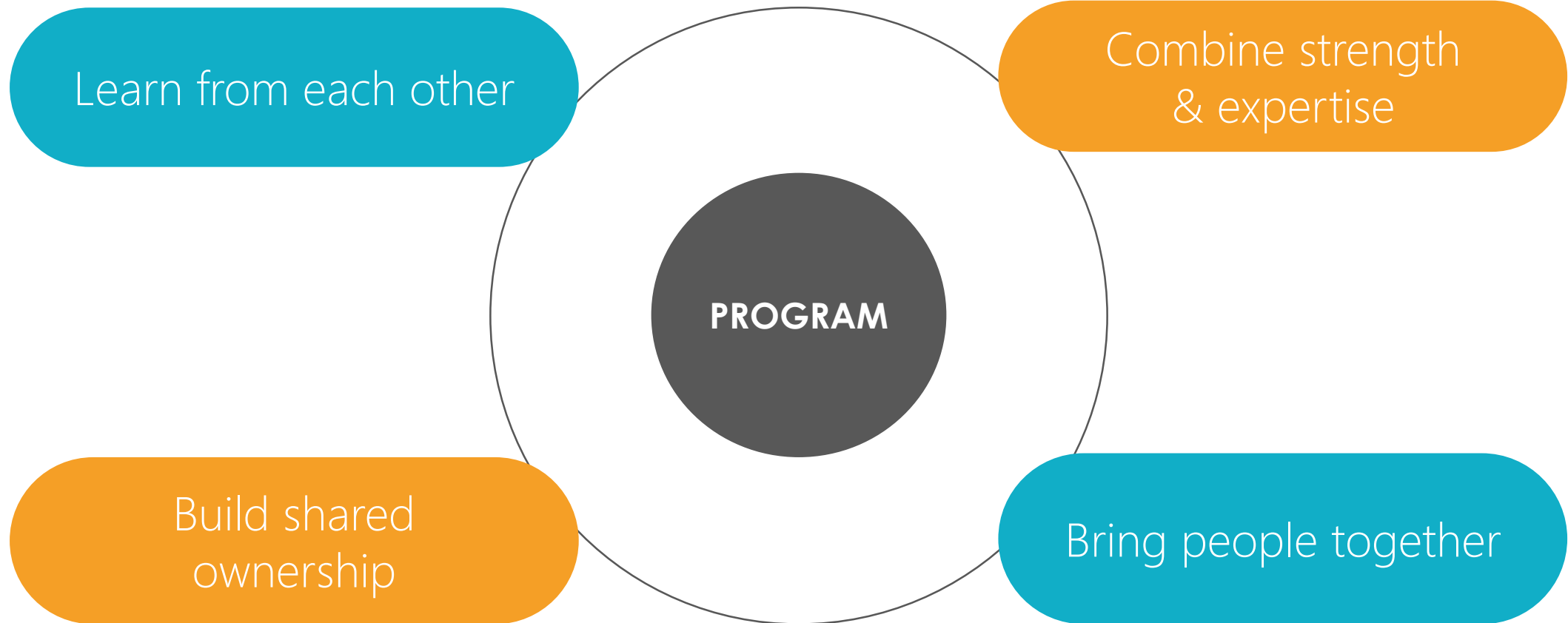

Importance of Collaboration

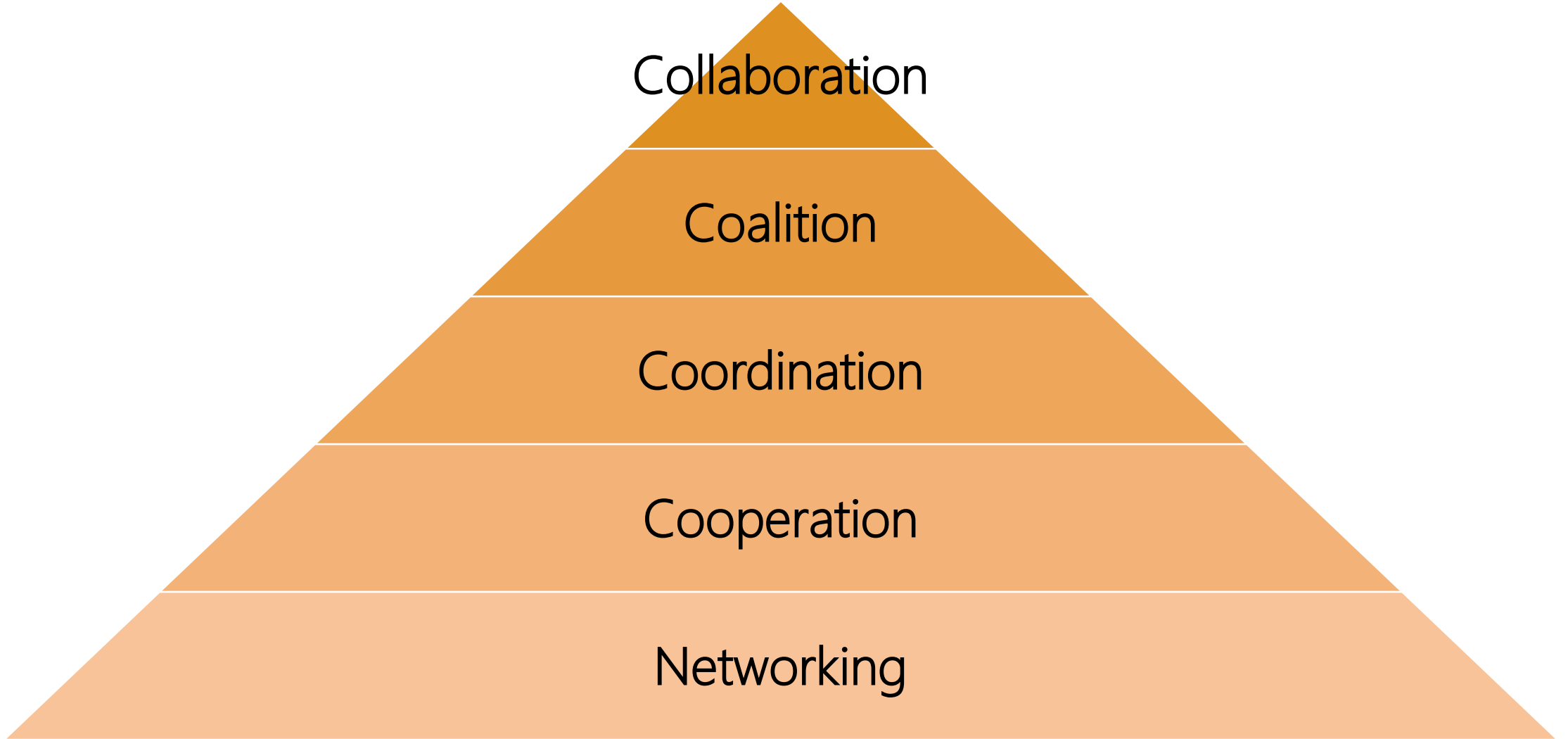


Importance of Collaboration in Tribal Truancy Prevention Programs

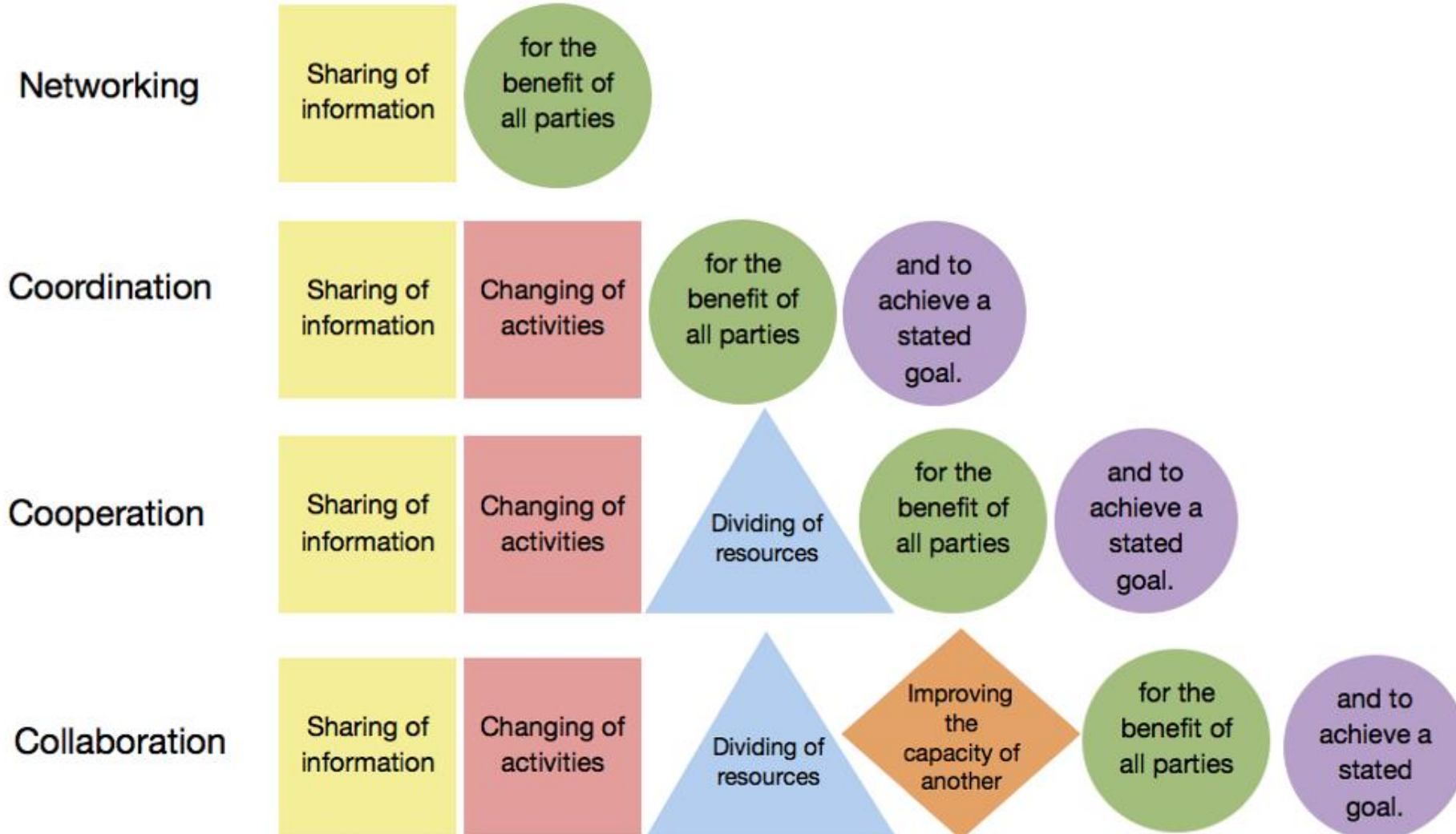


- Collaboration may be **essential to initiate operations** and program services. 90% of Native students attend public schools while 8% attend schools administered by the Bureau of Indian Education.
- **Requirements** within Federal and/or State consultation policies.
- The **enhancement of available services** that can be offered to youth as part of collaborative planning and development.

Five Levels of Collaboration

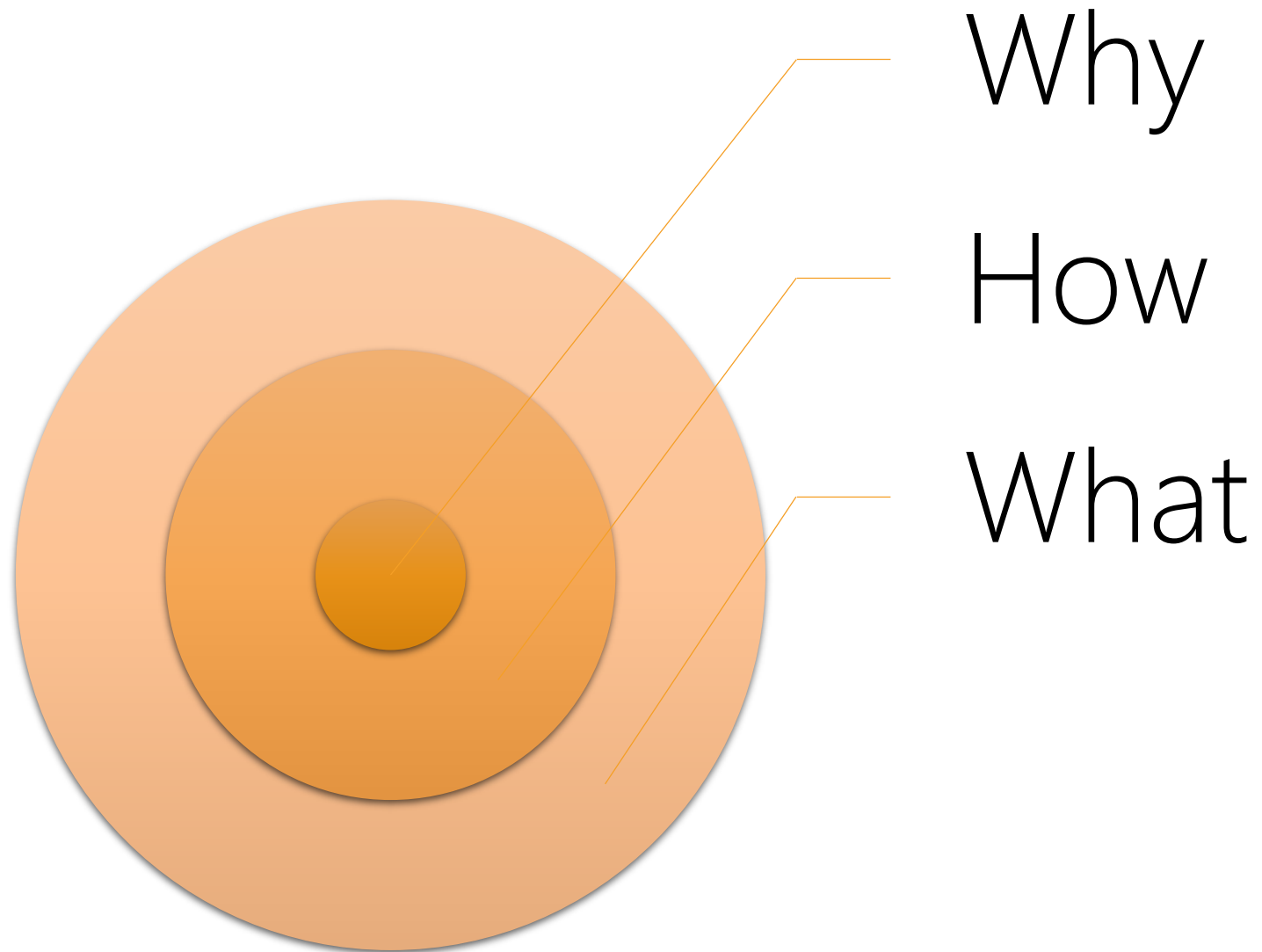

Start with Why



Factors that Influence Successful Collaboration

Environment

- Is there a favorable political environment?
- Is there a history of cooperation?

Communication

- Is there an established communication plan?
- Is communication clear?

Purpose

- Is there a shared vision?
- Are the goals obtainable?

Resources

- Are there sufficient funds, staff, and skilled leadership?

Factors that Influence Successful Collaboration, Cont'd

Membership Characteristics

- Is there mutual respect and trust among members?
- Are the right people involved?
- Does the purpose serve all?
- Is there flexibility among members?

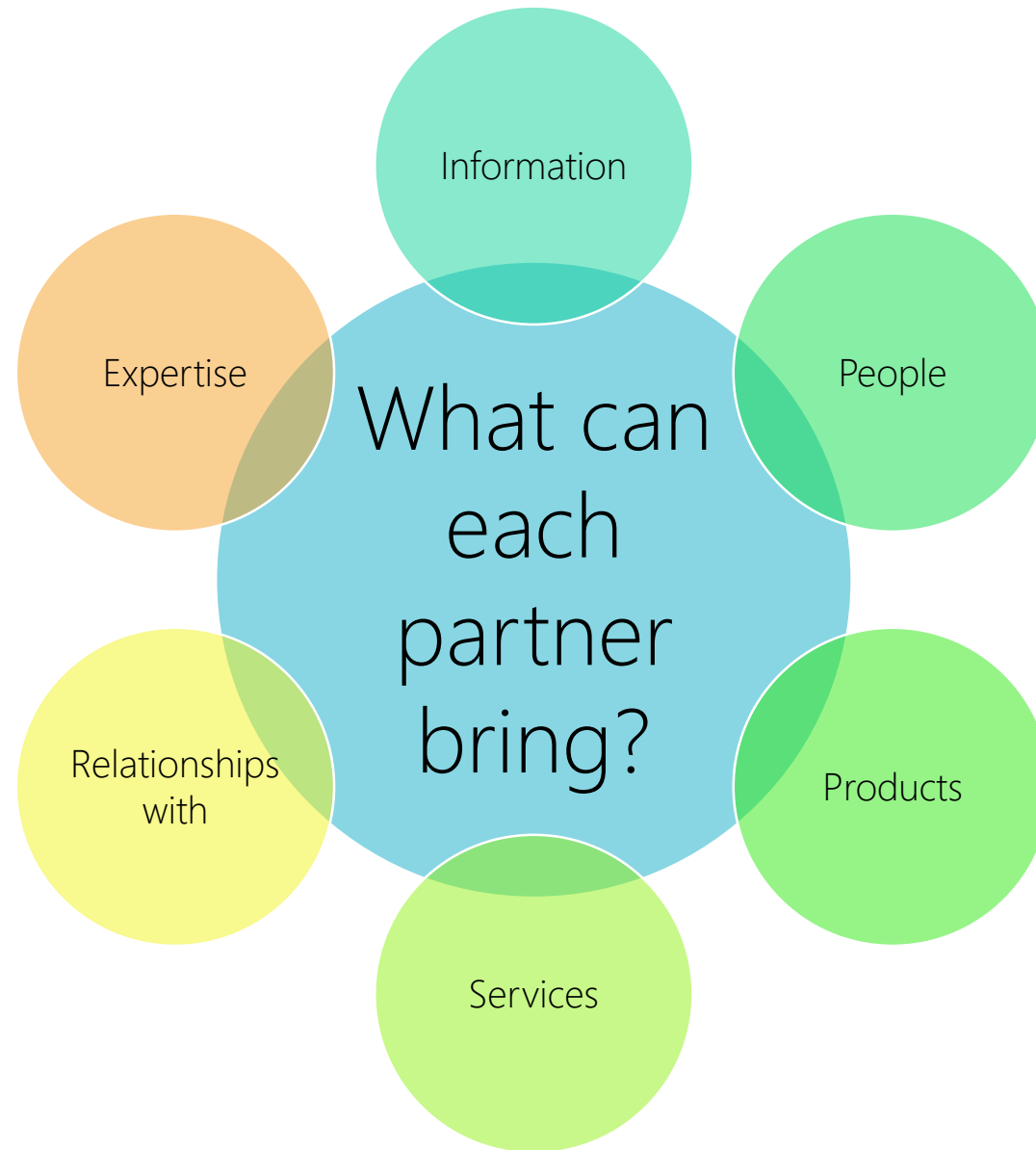
Process and Structure

- Do participants have clear roles?
- Has the group developed policies and procedures?
- Do all members have a stake in the outcomes?
- Is the collaboration able to adapt?

Picking Partners

- How will we develop a comprehensive picture of the individuals and organizations that have a stake in the issue we wish to address?
- What criteria will we use to determine who our partners should be?
- What will we do to ensure that we are not overlooking critical partners?
- How will we ensure the partners we choose are a good fit for our needs, goals, and culture?
- How will we reach out to potential partners?
- What will we communicate as the aim of the collaboration when reaching out to potential partners?
- Will we ask partners to formalize their participation in the collaboration in any way?

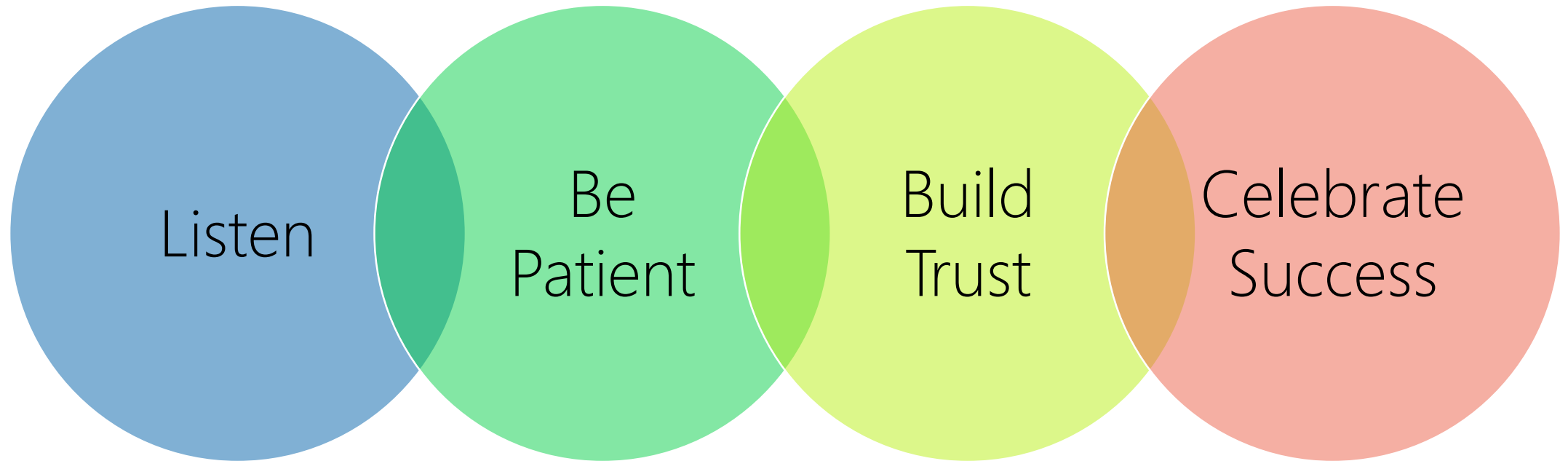
