

2. If there are already services available for low risk youth, but not for moderate to high risk youth, what services do you need to build out in your tribal system?

- Team-based case management or high fidelity wrap-around case management*
- High-level of structure, supervision, and accountability*
- Judicial supervision*
- Substance use disorder and/or mental health disorder treatment*
- Random alcohol and drug testing
- Participation in support groups*
- + Development activities (school attendance and success, employment, job training, and basic life skills)*
- + Enriched community connections (sports, clubs, youth groups, and volunteerism)*

Which youth do we want to reach with our JHW Court Docket?

- Two important concepts:
 - •Target Population
 - •Eligibility Criteria
- First, you will need to define your JHWC *Target Population*

• This will guide persons, entities, and/or government officials to do an initial vetting of potentially eligible youth

• If you provide them with a general description of the youth characteristics you are looking for, then they will report, transfer, or refer them to your JHWC



WHICH YOUTH DO WE WANT TO REACH WITH OUR JHW COURT DOCKET? (CONT.)

- Second, you will need to set your JHWC *Eligibility Criteria*
 - Your reporting, referral, and diversion sources may not have access to sufficient information
 - A history of serious offenses
 - The severity of the substance-use problem
 - Whether the parents willing to participate
 - After youth from your target population have been reported/referred/diverted to the JHWC, the JHWC Team will need to screen for additional, harder-to-identify characteristics
 - The JHWC Team will need *Eligibility Criteria*

How many cases involving Native/Tribal Youth are in state/county court? What types?

What types of "offenses" qualify for the JHWC?

Does the Youth have a substance use issue? How severe?

Have they tried treatment before (what type)?

What stage in the court process is the Youth in?

How old is the Youth, what gender?

What is the Youth's previous involvement with the Tribal/State justice systems?

FEDERAL DEFINITION OF "VIOLENT OFFENDER"

Per 34 U.S.C. 10612, any drug treatment court that receives funds under this program may not permit participation by *violent offenders*.

For the purposes of this solicitation, *the term "violent offender"* includes a juvenile who has been convicted of or adjudicated delinquent for a felony-level offense that:

- (1) has as an element the use, attempted use, or threatened use of physical force against the person or property of another,
- (2) the possession or use of a firearm, or
- (3) by its nature, involves a substantial risk that physical force against the person or property of another may be used in the course of committing the offense. 34 U.S.C. 10613.

Funding will be immediately suspended if DOJ determines that violent offenders are participating in any program funded under this solicitation.




CAUTION: AVOID "WIDENING THE NET"

- Avoid pulling lower-risk youth into a JHW Court Docket in order to get your program numbers higher
- A JHW Court is an intensive intervention most appropriate for moderate/higher-risk and need youth
- For youth who can be served by other tribal government programs, in community-based programs and/or in treatment, the JHW Court is an ineffective use of resources, may not benefit low-risk/need youth as intended, and may cause them harm
- If your stakeholders decide to serve low-risk/need youth, consider designing and implementing a JHW Program




JHWC Key Components, Guidelines, & Resources



The Tribal Healing to Wellness Court Key Components


